PLAN REVIEW FOR FOOD SERVICE

Please review the Colorado Retail Food Establishment Rules and Regulations. You will find the PDF of the 2013 Colorado Retail Food Regulations, as well as the **Plan Review Packet** and the **application for a Retail Food License** on the San Juan Basin Public Health (SJBPH) website.

To obtain a retail food license for an establishment, SJBPH must first review the building plans, menu, and other specifications. Plans for remodeling or construction must be submitted to San Juan Basin Public Health for review and advance approval. If you are purchasing or remodeling an existing restaurant you will be required to bring the facility up to current codes. We request 10 business days' notice to schedule your plan review appointment.

Licensing Also Requires

- Determine if the building under consideration has adequate space for your proposed operation;
 you must meet all equipment requirements for approval.
- Please note that a required application fee of \$100 is due and payable prior to the plans being reviewed. Submit the \$100 fee and application. A fee of \$60/hour will be applied for review of the application and preoperational inspection.
- Written approval of specifications and plans is necessary prior to starting construction. A minimum of two (2) weeks shall be needed for the department to review plans. Any revision(s) shall be submitted to the department for review and approval.
- Please contact SJBPH at least three (3) weeks prior to the contemplated opening and arrange for a final inspection. All construction and cleaning must be completed prior to opening inspection.
- Plan approvals and licensing take approximately 8 weeks.
- Upon approval, SJBPH will issue the Colorado Retail Food Establishment License.
- All Retail Food Establishments require a Colorado Sales Tax License.

- Check with County Building Department to review plumbing, grease traps and electrical regulations.
- Check with the Fire Department for regulations on vent hoods.
- Check with the City for business and liquor licenses.
